WHEREAS, such resolution should designate the individual authorized to ensure the application is properly completed and timely filed.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Maple Shade, in the County of Burlington and State of New Jersey, as follows:

- 1. That the Township Council of the Township of Maple Shade hereby designated Karen T. Zlotnick as the Township Recycling Coordinator, to ensure that the application is properly filed.
- 2. The monies received from the recycling tonnage grant be deposited in a dedicated recycling trust fund to be used solely for the purposes of recycling.

## TOWNSHIP OF MAPLE SHADE RESOLUTION 2021-R-47

## RESOLUTION REQUESTING A 3-MONTH EXTENSION OF TIME FOR AWARD OF A CONSTRUCTION CONTRACT FOR THE COMBINED FY2019 AND FY2020 MUNICIPAL AID GRANT FUNDED PROJECT.

**WHEREAS**, the Township of Maple Shade submitted Application MA-2019-Collins Lane-00013 requesting \$335,340.00 for resurfacing of Collins Lane from North Coles Avenue to West Roland Avenue;

**WHEREAS**, the New Jersey Department of Transportation (NJDOT) awarded FY2019 Municipal Aid grant funding in the amount of \$250,000.00 for resurfacing of Collins Lane from North Coles Avenue to West Roland Avenue;

WHEREAS, the Township of Maple Shade submitted Application MA-2020-Municipal Aid Program-00070 requesting \$433,320.00 for additional funding for resurfacing of Collins Lane from North Coles Avenue to West Roland Avenue; and for resurfacing of North Coles Avenue from Collins Lane to West Park Avenue;

WHEREAS, the NJDOT awarded FY2020 Municipal Aid grant funding in the amount of \$231,500.00 as additional funding for resurfacing of Collins Lane from North Coles Avenue to West Roland Avenue; and for resurfacing of North Coles Avenue from Collins Lane to West Park Avenue;

**WHEREAS**, the deadline for award of a construction contract for the FY2019 Municipal Aid project is March 25, 2021;

**WHEREAS**, the Township of Maple Shade intends to combine FY2019 and FY2020 NJDOT Municipal Aid grant funding into one construction project to provide cost effective use of the funds;

**WHEREAS**, the Township of Maple Shade is in the process of conducting utility work within the project limits. Sanitary sewer televising and repairs are being performed;

WHEREAS, during the design process Township of Maple Shade has requested incidental design modifications to the original scope of work. The original scope of work included replacement of broken curbing and broken sidewalk; construction of new sidewalk where none exists; construction of ADA-compliant curb ramps; pavement milling; resurfacing; striping and pavement markings. The Township has requested replacement of all existing curbing and driveway aprons for an improved project, resulting in the need for design modifications; **WHEREAS**, the declaration of a state of emergency by the Governor of New Jersey due to COVID-19 as well as the stay-at-home order has impacted staffing and work production on the roadway design plans;

WHEREAS, additional time is needed for award of a construction contract for the above reasons;

**NOW, THEREFORE BE IT RESOLVED** that the Township Council of the Township of Maple Shade, Burlington County, New Jersey, hereby requests a three (3) month extension of time to award a construction contract for the combined FY2019 and FY2020 NJDOT funded project, or until June 25, 2020.
