All warrants or checks for the disbursement of money shall be made by any three (3) of the following officials and facsimile signatures may be used:

- 1. Township Manager
- 2. Treasurer
- 3. Chief Financial Officer
- 4. Assistant Finance Officer

The Township Manager, Chief Financial Officer and Assistant Finance Officer are empowered to invest cash funs as bank balances will allow from time to time in order to realize a revenue. The above stated officers are authorized to transfer funds electronically for the purpose of investments and payroll only.

The following are authorized as suitable investments:

• Interest bearing bank accounts in banks as authorized above for deposit of local unit funds (GUDPA approved)

- Certificates of deposit in GUDPA approved banking institutions
- Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America. This includes instruments such as treasury Bills, Notes and Bonds
- Government money market mutual funds that comply with N.J.S.A. 40A:5-15.1(e)
- Any federal agency or instrumentality obligation authorized by congress that matures within 397 days from the date of purchase, and has a fixed rate of interest not dependent on any index or external factors
- Bonds or other obligations of the local unit or school district of which the township is a part
- Any other obligation with maturities not exceeding 397 days as permitted by the State Division of Investments
- Local government investment pools which comply with N.J.S.A. 40A:5-15.1(e) and conditions set by the Division of Local Government Services
- New jersey Cash Management fund
- Repurchase agreements of fully collateralized securities which comply with N.J.S.A. 40A:5-15.1(e)
- New Jersey Asset & Rebate Management Program
- New Jersey CLASS

This document shall constitute the cash management policy of the Township.

Any official involved with the selection of depositories, investments, broker/dealers shall disclose any material business or personal relationship to the manager and to the Local Finance Board or Local Ethics Board if applicable.

Any official who, in the course of his/her duties deposits or invests in accordance with this plan shall be relieved of any liability for loss.

- 4. Public comments may be submitted to the Township Clerk via email or written letter if received by 4 p.m. of the day of the meeting. Emails shall be sent to <u>publiccomments@mapleshade.com</u>. In the subject line, "Township Council Meeting Comment" shall be typed along with the date of the meeting. Written letters should state that the letter is being submitted as a Township Council Meeting comment and the date of the meeting for which the comment is submitted. Written comments will be read aloud at the meeting. Duplicative comments may be summarized at the discretion of the Mayor or presiding officer.

- 5. As provided for live meetings, the Mayor or presiding officer may, if necessary, because of the number of persons wishing to address the Council, limit statements to five minutes per speaker. As such, written comments will be read up to any stated time limit.
- 6. The Mayor or presiding officer may direct that a member of the public who becomes disruptive be muted and warned that continued disruption may result in the public member being prevented from speaking or removed from the remote public meeting. Disruptive conduct includes sustained inappropriate behaviors such as, but not necessarily limited to, shouting, interruptions, use of profanity and refusing to comply with the directions of the Mayor or presiding officer.
